In 1993, the Georgia General Assembly amended Chapter 30 of Title 36 of the Official Code of Georgia Annotated, relating to municipal corporations, to provide for the determination of inactive municipalities which do not meet certain minimum standards. The new law requires each municipal corporation in the state to file with the Department of Community Affairs a certification of active or inactive status. This form provides for such certification and will be used by the Department of Community Affairs to determine which municipal corporations meet the minimum standards as established in O.C.G.A. Sec. 36-30-7.1(b). On or after July 1, 1995, any municipal corporation not meeting the minimum standards shall be deemed inactive, and its charter shall be repealed by operation of law.
